Institute of Certified Professional Managers (ICPM)

A joint project initiated by CMA Sri Lanka and All India Management Association (AIMA) led to the formation of the Institute of Certified Professional Managers (ICPM). ICPM is a professional body that offers a professional Qualification and Membership for those seeking a career progression in Management, employed in Industry, Commerce or Service Sectors.

MEMBERSHIP

The Membership of CPM is of three grades and the details are as follows:

ACPM

Those who have full or part recognised qualifications and 3 years experience in industry or commerce.

MCPM

Five years after ACPM with minimum of 3 years Senior Management experience. This would mean a total minimum experience of 8 years with 3 years at senior management level.

FCPM

This grade of membership is applicable to those in senior management serving as CEO's MD's Directors, Chairman of Organizations. Those with 10 years after MCPM and employed in a senior management position with significant contribution to the management profession while in employment, practice, publications, research, faculty contribution, participation in CPM activities etc. will be awarded the Fellowship and designated Fellow Certified Professional Manager (FCPM).

10 years after MCPM or a total of 18 years experience, with minimum of 10 years in a senior management position (Director / Chairman).

Associate Membership	: Rs. 2,000/- per annum
Member	: Rs. 3,000/- per annum
Fellow Membership	: Rs. 4,000/- per annum
