BACHELOR OF MANAGEMENT STUDIES (BMS) DEGREE PROGRAMME CONDUCTED BY THE OPEN UNIVERSITY OF SRI LANKA

Application for Evaluation – Admission for Academic year 2018 / 2019

The Institute of Certified Management Accountants of Sri Lanka signed a Memorandum of Understanding (MOU) with the Open University of Sri Lanka, enabling CMA students to study for the BMS degree, with exemptions. This is an excellent opportunity for CMA students to complement the CMA professional qualification with a degree.

The degree is of four year duration – structured as level 3, level 4, level 5 and level 6. Students can specialize in **Marketing** or **Human Resource Management** in Level 6.

In terms of the MOU:

- Members / Passed finalists of CMA Sri Lanka can register for the BMS degree programme at level 5. (exempt from level 3 & 4)
- A student who has successfully completed the upto **Managerial Level** of CMA can register and offer the courses at level 5. He/she has to complete the CMA Strategic Level and gain exemptions from levels 3 & 4 prior to sitting for level 6 examination.
- CMA students have to satisfy Open University criteria regarding Continuing Education Courses in “Computer Literacy” and continuing Education Courses in “English for Academic Purposes”.
- Entry procedures and all relevant fees must be paid in accordance with directions of the Open University of Sri Lanka.

CMA students are accommodated for each academic year, and the names of CMA students to be enrolled for the BMS degree each academic year will be forwarded to the Open University by CMA Sri Lanka. You may complete the “**Application for Evaluation**” and forward to CMA Secretariat by **30-01-2018**.

Students who do not follow degree course (s) in any other university in Sri Lanka <u>will only be eligible</u> to apply for this program. 2. <u>First Preference</u> is given to students who have completed <u>CMA Passed Finalists / Members</u> and the <u>next preference</u> will be given to those who have completed the <u>Integrated Case Study, Strategic Level and Managerial Level</u> examinations. 3. A student, who has obtained exceptions for all the subjects of a stage, <u>shall not be deemed</u> to have completed that examination, to be eligible to be considered as an applicant for the Open University BMS Degree. Those who are have full exemptions up to Managerial Level also <u>not allowed</u> to apply. 4. Only students who have renewed this subscription up to year 2018 will be eligible to apply.
