#### CMA Sri Lanka Exemptions Policy

Please note the following important rules for CMA exemptions:

- Exemptions are only awarded at the discretion of CMA as per the exemption policy published.
- There is no automatic entitlement to exemptions. Where CMA determines that a qualification does not contain sufficient relevant coverage, no exemptions will be awarded.
- As a general rule, exemptions are granted only where a qualification has been obtained in full. Part qualifications will be considered for professional qualifications only.
- CMA does not award exemptions for exemptions received in prior qualifications.
- Exemptions will not be granted for subjects; a student has unsuccessfully attempted CMA examinations.
- Once a student applies for exemptions, a second request for exemptions will not be entertained unless he/she obtains full qualifications subsequently. In this case it is mandatory that the student attaches a certified copy of the previous letter with the new application.
- The student has to apply Exemptions through the "MYCMA" account.
- CMA does not award exemptions for professional experience.
- Only copies of official documentation signed and stamped by the awarding body can be accepted for exemptions. Online print outs of academic transcripts are not acceptable for the purposes of claiming exemptions.
- CMA has provided a list of qualifications for which it awards exemptions. Please note that CMA reserves the right to alter the exemptions at any given time, if required.
- Upon receiving an exemption, it will be updated in your MYCMA account. Please note that we do not provide any confirmation letters or transcripts for exemptions granted. Following the completion of at least one examination, you may request a transcript from the Examinations Division which will include the exemptions received based on your prior qualifications.
- Only for Conditional students:
  - Upon receiving an exemption, it will be updated in your MYCMA account. Please note that we do not provide any confirmation letters or transcripts for the conditional exemptions granted. You can obtain your result sheets, transcript, or any results confirmation letters after submitting the relevant documentation as proof of the qualifications used to obtain conditional exemptions.

Any application which does not conform to the requirements will not be entertained.

#### How to apply for Exemptions

- New students (Initially it is mandatory to register as a student with CMA to apply for exemptions) **Registered students (who have paid annual subscriptions**)
- Students can apply for Exemptions using the "MYCMA" platform only.
- Before applying for Exemptions, go through the "**Guidelines for Exemptions**". You will be required to be ready with certified copies of the relevant certificates and proofs scanned in PDF / JPG form to be uploaded in the relevant cage.
- Only Undergraduates, SLIATE, and Technical College Students to **Download "Form B"** as proof of current educational status.
- Please note that if any of your mandatory documentary requirements are missing the exemption application will be rejected. In such an event, you will have to re-submit the application with the correct documents.
- Supposing the CMA rejects your paid applications in the following scenario.
  - a. When proper authentication with the official seal in the proof document/ certificate is missing – you will have to reapply but need not pay again. (To obtain the already paid amount, after saving your documents with the proper authentications you must select the payment option of Using My Credit and must manually type the amount in the Debit cage and submit the application)
  - b. In case you are not eligible for Exemptions at all you may get a Credit Note for the amount paid and you will be able to use such credit for your future CMA payments.
  - c. If subsequently found any fraudulent information submitted at the time of applying, the Exemption fees will not be refundable.

#### Student Statement

Providing forged documents, or incorrect information will lead to strict disciplinary action and therein after cancellation of the studentship.

Upon reading and agreeing to the above-given exemption policy, you may proceed with applying for exemptions.

#### Important

1. Above mentioned table shows the maximum exemptions, a student can apply under each qualification. However, exemptions are evaluated case by case. Therefore, end results may vary from university to university and degree program.

Students are required to complete any qualification / specialized degree program mentioned in the grid to be eligible to apply for exemptions.
 Undergraduates / partly qualified professionals are advised to contact CMA – Marketing division for more information.

4. CMA will not consider any qualification obtained through exemptions; in other words, if you have received fully exemptions from any institute, then you are not eligible to apply for exemptions.

5. Granting exemptions is at the discretion of Education, Training and Research committee of CMA Sri Lanka

#### Frequently Asked Questions (FAQs)

- When can I apply for CMA Exemptions? You can apply for exemptions after the registration at CMA or later, but before sitting for the respective subjects which you wish to obtain exemptions.
- Can I apply for exemptions without registering as a CMA student? No, you should be a registered student of CMA to apply for exemptions.
- How can I get an idea on the exemptions eligible subjects? Refer the exemptions grid in CMA website. If your qualification is not in the Exemptions grid or if you are still an undergraduate, contact CMA Marketing Division (ext:134) for further inquiries.
- 4. I have more than one qualification. From which qualification should I apply for Exemptions? You can apply for exemptions based on all the qualifications. CMA will evaluate those and provide you the maximum exemptions based on your qualifications.
- 5. I am a graduate from a Foreign University. What are the documents that I need to send for the evaluation process.
  - 1) UGC's approval letter for the University from where the qualification has been offered.
  - 2) Transcript
  - 3) Detailed Syllabus

(Please check exemptions policy in the CMA website to check the documents which you need to apply for exemptions )

- I have failed CMA subjects before but now I have completed my degree/professional qualification. Can I obtain the exemptions for failed subjects? No, you cannot obtain exemptions for already failed subjects.
- How many times can I obtain exemptions? You can apply exemptions only two times per qualification. Once you get partly qualified, you can apply, and the next request will be entertained only once you complete the qualification fully.
- Can I do the exemptions payment in installment basis?
  No, you cannot make the exemptions payment in installment basis.
- 9. Can I get a confirmation letter or a certificate for the granted exemptions? No. Please note that we do not provide any confirmation letters or transcripts for exemptions granted. Following the completion of at least one examination, you may request a transcript from the Examinations Division which will include the exemptions received based on your prior qualifications. Upon receiving an exemption, it will be updated in your MYCMA account.
