## Technology Modules – Skill Stream

The following four modules will be conducted under the Technology Module by the CMA Computer Center.

- Operational Level -OL2.6 : Information Technology Application [ITA]
- Managerial Level -ML3.6 : Data Analytics [DA]
- Strategic Level -SL4.6 : Digital Tools for Accountants [DTA]
- Strategic Level -SL4.7 : Advanced Data Analytics [ADA]

Workshops are conducted online (through Zoom) and physically all the technology modules are by CMA Computer Centre.

### Study Material

The study texts of all the modules are available with the institute and practicing questions are given during the workshop.

### Application

- Can apply for a Workshop via the MYCMA learning portal.

### Course Regulations

- Required to maintain an 80% attendance for classes.
- If fail or absent for the exam, will be able to complete at the next immediate batch by paying the relevant fees, if not you will have to sit for the exam again by paying the total fees.
